#### **Stop Signs**

As more and more folks have discovered that Beckett's Ridge Drive is the only connector between Old and New 86 (aside from I-85), the traffic along Beckett's Ridge Drive continues to increase. When this fact is combined with the fact that our neighborhood streets are long and narrow, issues of safety and quality of life are raised.

The Hillsborough Town Board has recently ruled that it plans to allow all traffic from the proposed Waterstone development (or whatever eventually is developed on the same land) to empty out at our back entrance at Beckett's Ridge Drive, so the thru-traffic in our community is only poised to get worse.

Today, the number of reports to the HOA regarding run-down street signs, hit mailboxes, stop sign running, and speeding has forced the Board of Directors to look into pro-active measures by which traffic in our community can be calmed.

In the last newsletter, the HOA Board asked you what options

to calm traffic you would like (Stop Signs, Speed Bumps, Lower Speed Limit, etc.). One of the most requested solutions was adding additional stop signs. As a result, the HOA Board of Directors asked the Town of Hillsborough to install three additional three-way stops along Beckett's Ridge Drive in an effort to address the aforementioned safety concerns.

Three new three-way stops have been installed at the following intersections along Beckett's Ridge Drive:

- Beckett's Ridge Drive at Kennesaw Court
- Beckett's Ridge Drive at Savannah Court
- Beckett's Ridge Drive at Scottsburg Trail

It is the HOA Board of Directors' desire that these additions will help address some of the concerns regarding traffic safety in our community. As always, the HOA Board welcomes any comments or additional suggestions that can be implemented in order to make things better in our community.

## Elizabeth Brady Road Information Meeting

An informational meeting on the only proposed solution to traffic congestion on Churton Street, Elizabeth Brady Road Extension, was Monday July 7th.

Beckett's Ridge Residents should be particularly interested of the impacts of this proposed road improvement because it directly impacts Highway 86 (New 86). If built, Elizabeth Brady Road Extension would provide another route to get from the South side of Town to the North side of Town and vice-versa. Currently, there is only one route ... through Downtown Hillsborough on Churton Street.



#### Voter Registration

The Town of Hillsborough holds Town Elections every odd numbered year. This November, all residents of Beckett's Ridge will have the opportunity to vote for the Mayor of Hillsborough and three seats for Hillsborough Town Commissioner. If you are new to the community (or even if you have lived here for a while), please make sure your voter registration is current so that you can vote. The number of registered voters in Beckett's Ridge is significant. Significant enough, in fact, that Beckett's Ridge residents could determine who the Mayor and Town Councilmen of Hillsborough would be if everyone got out and voted. Just remember, we all live in the Hillsborough City Limits and that makes us fully entitled to vote and participate in our Town just like anyone else. You can call the Orange County Board of Elections to change your voter registration. Their number is 245-2350.

#### Town Sidewalk Forum

Fliers will be passed out in the future announcing a community sidewalk forum. The Town of Hillsborough will be allocating \$20,000 per year to build sidewalks throughout Hillsborough. As a part of the process, the Town is soliciting ideas and opinions about where sidewalks need to be placed. At some point in mid-July (the date has yet to be determined), there will be a sidewalk forum for the South side of Town. Fortunately, Beckett's Ridge isn't as bad off in terms of sidewalks as the rest of the Town, however, there may be some places we need sidewalks. Attending this forum and giving your input would be helpful to the HOA Board and Town of Hillsborough in determining where those locations might be. Please keep your eyes out for an announcement of this meeting.

"Of course, right away, we'll need to address the budget and other issues that every school system is facing, such as the No Child Left Behind legislation."
